**Re: Freedom of Information and Protection of Privacy Act Request,
Our File #: MMAH 2024-128
Access Decision Letter**

Dear Leah Dyck,

This letter is in response to your request made pursuant to the Freedom of Information and Protection of Privacy Act (the Act) received on June 29, 2024, for the following:

- This is a request under this jurisdiction's freedom of information legislation for records held by The Ministry of Municipal Affairs and Housing.
I'm seeking a list of all the property addresses in the Barrie Municipal Non-Profit Housing Corporation (BMNPHC) property portfolio, as well as a list of all the property addresses in the Simcoe County Housing Corporation (SCHC) property portfolio, as of June 29, 2024.
 - For each property, how many one bedroom units are there? Of these, how many are subsidized units?
 - For each property, how many two bedroom units are there? Of these, how many are subsidized units?
 - For each property, how many three bedroom units are there? Of these, how many are subsidized units?
 - For each property, how many four bedroom units are there? Of these, how many are subsidized units?
 - For each property, how many five bedroom units are there? Of these, how many are subsidized units?

Finally, if properties have changed portfolio's between January 2008 and June 2024, we need a list of the properties that changed portfolios, including the date in which the change occurred.

- Time period: From January 01, 2008 to June 29, 2024

A decision has been made by Martha Greenberg, Deputy Minister of the Ministry of Municipal Affairs and Housing to withhold records in full.

Records are exempt under section 22(a) of the Act - Information available to the public.

You may request the Information and Privacy Commissioner to review this decision within thirty days from the date of this letter. You can do so by filing an appeal online at www.ipc.on.ca. The appeal fee is \$25.00 (for general record requests) or \$10.00 (for personal information requests). Alternatively, appeals can still be mailed with a cheque or money order payable to "Minister of Finance" to: Registrar, Information and Privacy Commissioner of Ontario, 2 Bloor Street East, Suite 1400, Toronto, ON, M4W 1A8.
