Good morning Angela. My name is [REDACTED] I live at 90 Edgehill Apartment 301. I'm just wondering why it's saying I owe almost \$2000 for rent when I log into my DMS portal. I was told that the only thing that was needed to update my file was the request for OW form, which my worker faxed into the office here a couple months ago. At that time, my portal was updated, my rent was paid and it was showing I owed \$0.00. In the past month, I've been texted from someone else in the building, more than once, threatening me that they were going to tell the building my paperwork from OW is fraudulent, and now I'm being asked for more paperwork that I've already handed in. OW pays my rent directly to the building. I don't feel comfortable talking in the office here about anything anymore, because nothing is kept in confidence. I've talked about private, personal things in the office here, including why I was put on the priority housing list and why I couldn't afford certain things, such as a harness for my ESA. These things have been repeated back to me from other people in the building. I'm a human trafficking survivor and the things that go on here, not just with the tenants but the fact nothing in the office is kept confidential, is anxiety inducing and there's been way too many times I think my life would be easier if I had my trafficker controlling me again, instead of dealing with living in this building. I have seen my attacker who sexually assaulted me and a few other people I've been trying to not be seen by as court stuff for these people is still ongoing. My safety is at risk because of this. I'm requesting that if u have anymore rentals, not in this building, if I can be moved, for safety and my mental health. You can contact Elisha at Victims Services if you need anymore information regarding the ongoing human trafficking case, so u know how sensitive this matter is. She can be reached at 705-725-7025 ext 2120. You can also talk to Detective Jeff Wright, who is the head of the human trafficking division. He can be reached through Elisha, I'm not sure if I'm allowed to give his cell number out. Thank you for your time.

Thank-you for your patience. MPP Khanjin has been working with Brad Spiewak, Director of Social Housing and Greg Bishop, General Manager of Social and Community Services Division for the County of Simcoe to try to find a solution. She has kept your name private.

She was advised that tenants are allowed to request an internal transfer. It should be noted that due to the extreme shortage of housing and number of tenants on the internal transfer list, it can take a significant amount of time for the next available unit to become available and the tenant get moved into another unit. Have you requested to be on that list?

MPP Khanjin was advised that the "affected tenant" would be highly encouraged to contact the police and file for a no contact order. That gives them the strongest case to issue appropriate notices and pursue eviction or the no trespass order for a non resident.

One other option that could be possible depending on the tenants finances would be to leave the Rent Geared to Income (RGI) building and receive a rent supplement or portable housing benefit. This would allow you to reside at any private landlord you can afford, receiving a financial monthly benefit to bridge the rent cost. Unfortunately though, if this does not work out you would then have to reapply for rent geared to income housing within the context of the Centralized Waitlist for RGI.

MPP Khanjin was also advised that it may be of further assistance for the tenant to seek outreach services from the local women's shelter if you have not already connected to these supports. Services and supports available specific to developing a safety plan and assisting with legal processes such as pursuing a restraining order and engaging with police services may also be appropriate and helpful.

Beyond the options previously outlined, there may be some availability for limited financial assistance to support relocation based upon the described safety risk through the County's Housing Retention Program. Please see link below for ease of access to the webpage outlining details of this program and the application process.

Please be advised that I require support of another individual in my on-going care because of disability resulting from undiagnosed and untreated ADHD and ASD, as well as an untreated TBI at age 20; untreated C-PTSD resulting from childhood trauma from abuse, untreated trauma from spiritual/religious abuse, and untreated trauma from intimate partner abuse that began with my first intimate partner in my late teens and every intimate partner subsequent to him, including the most recent one as of last year.

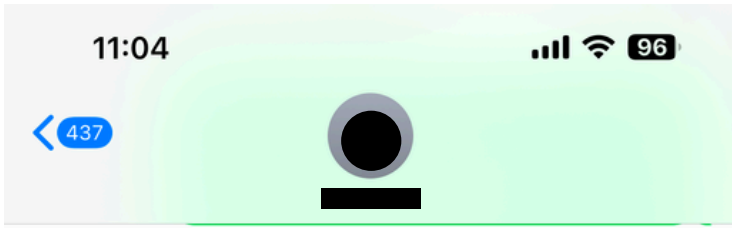
With regards to undiagnosed and untreated ADHD and ASD, both conditions are diagnosed in several blood relatives including: my older sister; two of her three children; one of my two children, but likely the other is undiagnosed; and the likelihood that our mother is also undiagnosed.

For all of these factors, I am declaring my sister as part of my Circle of Care and she is permitted to be present at any of my appointments and to receive information about my care. This support is a necessity for me as I am barely able to carry out daily functions.
